INTRODUCTION

All Cadets are subject to these regulations.

IMPLEMENTATION

Cadets are governed by this distinct Virginia Tech Corps of Cadets (VTCC) uniform instruction. Overall supervision and policy is the responsibility of the Commandant of Cadets through and by his staff. Day-to-day operations of the Corps of Cadets are the responsibility of the Cadet Regimental Commander. They are carried out by leadership supervision, guidance, and direction of a staff of cadet officers and subordinate cadet commanders per those regulations below.

RESPONSIBILITY

It is the responsibility of <u>all cadets</u> to be familiar with this instruction. The Regimental Commander, under the cognizance of the Commandant of Cadets, may amend these regulations by utilizing General Standing Orders.

CHANGES

Changes to this regulation are as follows:

- Coordinated by the Deputy Director of Operations.
- Submitted electronically (i.e., pdf, email, survey form) to the commandant staff member responsible for collecting proposed changes.
- A finalized version shall be published each June.
- The Spring Semester REGI CSM
 - Should review the proposed changes prior to publication
 - Should coordinate with the Deputy Director of Operations in preparation for presenting the proposed changes to the Commandant if feasible.

NOTE: Every effort should be made to include cadets in the revision process to ensure the Cadet perspective is maintained.

FINAL WORD

In the end, no regulation, set of policies, or guidelines can cover every foreseen and unforeseen circumstance.

CHAPTER 1: PHILOSOPHY & POLICY

Each cadet is responsible for wearing a proper uniform and maintaining a sharp appearance both on and off duty. The purpose of this chapter is to establish policies for the proper wear of the cadet uniform. Normally, cadets who are being recognized, inducted into an organization, or otherwise representing the Corps of Cadets, should do so in cadet uniform. Policy: Uniforms will be worn Monday through Friday, during the Corps "business" hours as specified later on. Uniforms will be worn to all official university and/or Corps events and duties. If attending a Corps- sponsored event, exceptions to this rule will be noted via OPORD.

Since the cadet uniform is created to support the institution of the Corps, its values, and its underlying training programs, it is not appropriate to wear elements of the Corps uniform, either partially, or as a whole, to an event that has not been formally sanctioned and approved by the Commandant or his/her staff. The same holds true for all uniform items issued as part of any of the Reserve Officer Training Course (ROTC) programs at Virginia Tech., Wearing elements of uniform items issued by ROTCs is subject to sanctions and approvals by the leadership of an appointed Detachment Commander.

In general, cadet uniform wear is directed through Regimental Orders (ROs), Operational Orders (OPORDS), and the Cadet Regulations. Requests for wear of the Corps uniform items to activities not covered by the ROs, approved OPORDs, or the Cadet Regulations, should be coordinated with a Senior Enlisted Advisor and/or Deputy Commandant. The same procedure applies for the use of ROTC uniform elements, through the ROTC Detachment Commander or their designated representative(s). If a cadet/midshipman is receiving an award, recognition, or induction from a university, military service-related, or professional organization, the wear of a Corps/ROTC uniform is appropriate. When in doubt, check with a Senior Enlisted Advisor / Deputy Commandant or ROTC Detachment staff official.

An exception to this policy is the use of Corps / ROTC- provided footwear which is designed to protect a cadet/midshipmen's feet. However, it is important to note that abuse of this exception (using the footwear in extreme conditions) that results in excessive wear and tear leading to replacement, may require the cadet/midshipmen to pay for their replacement. Any overuse that results in excessive wear and tear because of this exception will not be reimbursed. Cadets/midshipmen can expect to pay for their own replacements.

The intent is to ensure that cadets participating in activities outside the construct of the Corps or ROTC programs do not inadvertently (or intentionally) create the impression that such activities are sanctioned or supported by the Corps or ROTC programs, by the wear of issued uniform items

NOTE: All town cadets will comply with all published uniform regulations.

The carriage of a personal "military" knife should only be at times where its use might be warranted (e.g. field training exercise) and thus would only be carried when wearing OCP/ROTC camouflage uniform, and in no other uniform...not in white shirt / gray bag and higher.

PROCESS FOR UNIFORM CHANGES

Units and Corps Organizations are permitted to design patches and other uniform items for their respective groups. Cadets are also allowed to recommend Corps wide uniform changes. The use of the VT logo requires higher university approval. Images of weapons cannot be paired with the VT logo. Tasteful images of weapons are permitted when not combined with the VT logo. The process for a unit to customize a uniform item or for a cadet to recommend a proposed change is described below.

- Use Docusign request process to route a proposal with <u>detailed design</u> to unit Advisor or Deputy Commandant if an item for BN/Company or a Corps uniform change.
- Once approved/signed by Advisor or Deputy Commandant, route to the Communications Director for review if it includes graphics of any kind for approval/signing.
- Next route to the Business Manager for Commandant approval and funding determination. If a unit specific item, funding will most likely need to come from the organization self-generating account. If a Corps uniform change, item will be part of the Tailor Shop budget.
- Once funding is determined and approved by the Business Manager, orders will be placed by the Corps Finance Team.

ENFORCEMENT

These regulations define the composition of authorized uniforms. VTCC uniforms are distinctive visual evidence of the authority and responsibility vested in their wearer by the Corps leadership and those who have worn it since 1872. The Prescribing Authority determines when and where the uniforms in this manual are appropriate for wear. Additional uniform enforcement notes are as follows:

- All <u>personnel</u> shall comply with these regulations and be available to teach others the correct wear of Corps uniforms.
- Uniforms and components shall be worn as described in these regulations.
- Cadets must present a proud and professional military appearance that will reflect positively on the individual, the Corps of Cadets, & Virginia Tech.
- While in uniform, it is inappropriate and detracts from a professional appearance for personnel to have their hands in their pockets.
- When walking from point to point while in uniform, it is inappropriate and detracts from a professional military appearance for personnel to be smoking or using tobacco products, or to be eating and/or drinking.
- Exemplary appearance should be the norm for all cadets.

NOTE: These regulations describe **all authorized** Corps of Cadet uniforms and the proper manner for their wear.

STANDARD PHRASEOLOGY

When making official references to the uniforms, insignia, and grooming standards in any official publication, the terms set forth in these regulations shall be used.

Basic Uniform Components

Uniform items required as part of the basic uniform. These are the minimum items which must be worn unless the prescribing authority directs otherwise.

Prescribable Items

Uniform items which may be directed or authorized for wear with the basic uniform. Prescribable items may be worn with basic uniform at the individual's discretion unless otherwise directed.

Optional Items

Uniform items purchased at the wearer's expense, which may be worn with the basic uniform, but which are not prescribable. Optional items may be worn with the basic uniform at the individual's discretion unless otherwise directed.

Uniform Distraction

Obvious to the eye, attracting attention, striking, bright in color, exaggerated appearance. If the item worn or manner of wear of any uniform component naturally draws attention away or deters from the professional appearance of the individual in uniform, it is a uniform distraction.

Conservative

Not detracting from the professional military appearance while in uniform. Traditional non exaggerated appearance aligned with projecting a proper military image.

Complementary Appearance

Contributing to the individual's/wearer's natural appearance. Having a subtle and natural appearance. Conservative and not exaggerated.

Phase-Out

Discontinue wear.

Organizational or Unit Component

Any group within the Corps Cadets that has been sanctioned by the Commandant. Units include, but are not limited to the Regiment, Battalion, Company, or Operational Organizations.

CHAPTER 2: GENERAL COMPONENTS

ACCESSORIES

- Under no circumstance will any device denoting membership in any unrecognized society or organization be worn or carried while in uniform.
- Female cadets may carry a small plain black purse with the uniform at any time except for drill and formations.
 - Straps will not be worn over the shoulder.
- Cadets may wear a backpack or bag with straps over both shoulders while wearing the service uniform, OCPs, PT gear, or Hokie bag.
 - The backpack or bag must be black, and conservative in nature.
- At no time will obsolete uniform items be worn once the items have been discontinued for authorized wear.

EYE WEAR

- Eyeglasses and nonprescription sunglasses that are conservative in nature are authorized.
- Frames may not be extreme or trendy colors.
- Brand name glasses may be worn with small logo on frames or lenses. Logo may contrast with frame color or lenses.
- Cadets may not wear lenses that are extreme or trendy in color. Lens colors must be traditional black, gray, brown, or dark green shades. Lenses cannot be mirrored.
- Sunglasses (to include darkened photosensitive lenses) are not authorized in formation. [Exception: Unless for medical reasons, e.g., PRK/Lasik surgery.]
- Conservative wrap-around sunglasses may be worn.

JEWELRY

Rings

- Shall be conservative.
- May consist of natural metals or fabricated materials (i.e. plastic, wood, silicone) and may be gold, silver, copper, gray, tan, brown, black, white or light pink in color.
- Only one ring per hand is authorized, plus a wedding/engagement ring set.
- Double stacking wedding rings with military academy/education institution rings are authorized on one hand.
- Rings are permitted to be worn on the thumb.
- Rings shall not present a safety hazard.

Bracelets & Watches

- Only ID, medical, and POW/MIA bracelets are authorized in uniform.
- Watches must be of a conservative color. No extreme or trendy colors are authorized in uniform.

NOTE: Non-ID/ medical bracelets and watches that are rubber, beaded, paracord, or flashy are not permitted in uniform.

Necklaces

- Shall be conservative in nature.
- Shall be concealed while in uniform and not be seen hanging over a cadet's uniform.

MEDICAL

- If a cadet has an arm or hand injury, the uniform of the day will still be worn unless it is impossible to do so.
- A cadet with any foot or leg injuries that require the use of crutches may wear VTCC OCPs, foot or leg injuries not requiring the use of crutches will result in the wear of the UOD
- Athletic shoes may be worn with a foot or leg injury as per a healthcare provider's instructions.

GLOW BELT

• During the period of sundown to sunrise a reflective (i.e., glow) belt shall be worn for training, personal fitness, and organized PT.

UMBRELLA

- A plain black umbrella is authorized for carry with any uniform, except for drill or formation.
- No color other than black may be used.

EAR MUFFS

Solid black ears muffs are authorized to wear with the following uniforms/uniform items:

- Windbreaker with wheel covers
- Fleece with patrol cover
- Parka with patrol cover
- Paletot


HEADGEAR

Service Cover (Wheel)

The cover will be worn centered on a cadet's head, with the visor two finger widths from the nose. The wind strap will be worn as follows:

- The wind strap (at the rear of the cover) will be buckled in the first hole and cut so that, when worn, the buckle and strap-keeper are centered on the rear hat seam as shown in the *Guidon*
- The wind strap-keeper (tab) will be trimmed, so that the "hole" side will not extend past the band piece near the buckle.
- Leather Luster, Shape-Up, or other comparable products will be used to shine the wind strap. In addition, all holes, edges, and the buckle will be likewise blackened. At no time will the shine be cracked or have spots worn away.
- The edges of the wind strap that attaches to the wheel cover, closest to the headlight hole, will be trimmed, so that they cannot be seen when wearing the wind strap down.
- The wind strap may be worn down by any upper-class cadet and will be no more than three finger widths from the bottom edge of the cover. First-year and New Cadets are authorized to wear the wind strap down only if directed by the unit commander in his/her chain of command or during extremely windy conditions.
- The grommet will be worn upright, shined smudge-free, and centered on the cover. Headlights will be oriented vertically at all times.
- Black hat bands (chin straps) will be worn by all non cadet officers, gold chin straps will be worn by all cadet officers, silver chin straps will be worn by fifth-year cadets
- The clear plastic service cap cover must be worn when the trench coat is prescribed for formations unless otherwise directed by the Regimental Commander. For daily wear to class and other cadet activities during the duty day, the plastic service cap cover is an option. If the cap cover is worn, however, the cadet must wear the raincoat, not just the cap cover itself.

OCP Patrol Cover

- Shall be worn on the head to create a straight line around the head of the Cadet, with the band parallel to the ground. It will fit comfortably and snug on the head, with no visible hairs on the forehead, without distortion of either the cover or the wearer.
- The visor will be bent, creaseless, in a curved fashion to form a natural blocking of sunlight for the wearer. The visor and sides of the cover will be two finger widths from the nose and ears, respectively.
- Patrol covers will be worn in OCPs and Modified OCPs at all times and may be removed when:
 - Performing physical training or manual labor (ie. on the O-Course)
 - When use of patrol hinders ability to perform an objective (ie. rappel ops) or causes unsafe operating conditions.
- The OCP patrol cap shall be worn by non-officer cadets with the Corps crested pin and cadet officers with the gold VPI pin. These specifications will be worn at all times except during ROTC labs when ROTC uniforms are prescribed.
 - Both the Corps Crest and gold VPI pin will be worn centered vertically and horizontally on the front of the cover.
- First-year cadets will not wear anything on their patrol covers.
- May be worn with parka in absence of the watch cap.

NOTE: The Corps Crest will not be subdued, hidden, modified, or disgraced.

Berets

Berets can be worn in VTCC OCPs after formation and in applicable ROTC uniforms by cadets in the following organizations:

- Ranger Company
- Armed Forces Special Operations Preparatory Team (AFSOPT)

Watch Cap (Beanie)

• Authorized in full or modified OCPs when worn with an outer garment, in PT gear with proper cold weather gear, and when prescribed with outer gear.

HEADGEAR RELIGIOUS ACCOMMODATIONS

- Cadets may request a waiver, based on religious accommodation, to permit wear of neat and conservative (defined as discreet, tidy, and not dissonant or showy in style, size, design, brightness or color) religious apparel. The default color for religious apparel would be anticipated to be black. This will be passed through the cadets chain of command and be physically or electronically signed.
- If the cadet is also enrolled in an ROTC program, then they will be expected to comply with that Service's religious accommodation policies and must coordinate a request with them prior to arrival on campus.
- The following head coverings are included (but not limited to) in this guidance: hijab, turban, kufi, kippah, or yarmulke.
- Except in the case of safety or protective headgear required by a cadet's duties, position or assignment, cadets granted a religious accommodation for head coverings are not required to wear military headgear in addition to their religious head covering if such military headgear would violate their held religious beliefs.

TROUSERS

- Trousers shall be worn in the following manner:
 - Extend to shoes, touch the laces, and cover socks (i.e., not visible) when worn in the standing position with shoes on.
 - The bottom edge of the trousers shall rest lightly on the top of the shoe, creating a slight break in the crease
 - o "High Waters" are not authorized.
 - The trousers are fitted to be worn so that the top of the pants (waistband) is flush with the belly button.
- Will be kept clean and pressed with creases down the front and back of the legs.
 - Creases will start at the bottom of the trousers and end at the bottom of the crotch seam.
- Any tears, loose side stripe, etc. should be brought to the tailor shop for repair as soon as possible.

SKIRTS

- The skirt is authorized but optional for all female cadets
- The skirt shall be worn in the following manner:
 - Worn with skin tone nylons.
 - Worn with proper heels.
 - Worn how it was fitted either at top, middle, or bottom of the kneecap.
- May be worn to formation and during prescribed service uniform days.

NOTE: Large, protruding objects will not be placed in the pockets during formations, including phones.

NECKWEAR

- A black necktie purchased or issued from the Tailor Shop will always be worn with the winter service gray long sleeve shirt.
- A full windsor knot (symmetrical tie knot) will be used.
- The necktie will be tucked in between the second and third buttons from the top.
 - A 45 degree angle will be made where the tie folds under itself.
- Females may substitute a tie tab where a necktie is designated.

NOTE: Only cadet officers will wear their ties untucked and wear tie clasps. Any formal military, business, or VT clasp in good taste may be used. The tie will fall between the top and bottom of the belt buckle.

BELTS

Cadet Officer and Non-Officer Cadets shall:

- Wear VTCC black belts at all times when wearing the gray trousers.
- The buckle will be fastened at all times and the grommet on the buckle will be highly-shined, smudge-free, & free of scratches.
 - Two leather loops, crisscrossed, will be used to secure excess portions of the belt.
 - As worn, the loops will be crisscrossed in the same manner as the cadet cross belts, with the inner one going from top right to bottom left, and the outer one going from top left to bottom right.
 - The crisscrossed loops will be adjusted to touch the belt buckle.
- Leather Luster, Shape-Up, or other comparable products will be used to shine the black belt. At no time will the shine be cracked or have spots worn away.

First-year cadets shall:

- Wear the white cloth belts with the brass buckle and clip.
- Dirty or worn white belts will be washed or replaced as needed.
- Brass buckles will be shined, smudge-free, & free of scratches.
- No "flags" should be visible.
- The black belt will be worn as follows:
 - When drilling with a weapon or when on guard.
 - When serving as a member of the flag detail (spring semester) as designated by the Regimental Commander.

FOOTWEAR

Low Ouarters

- Shoes may be of genuine or artificial leather, but either will be highly shined at all times, free of dirt, and will have fresh shoe edge dressing.
- Artificially shined low quarters are not authorized for formations or inspections.
- Will be worn with black dress socks.
- Unserviceable low quarters should be taken to the tailor shop for replacement.

Brown Dress Shoes (optional)

NOTE: Brown shoes are <u>not</u> issued by VTCC and <u>must</u> be purchased by cadets as an optional item.

- Are only authorized with Hokie Bag.
- Will be worn with black, gray, or brown dress socks.

Combat Boots

- Black, coyote, or olive boot socks will be worn with combat boots.
- Coyote boots will be worn with OCPs and will be kept clean and free of grass stains.
- Unserviceable VTCC issued boots shall be taken to the tailor shop for replacement.

NOTE: Cadets may purchase their own boots as long as they are coyote in color.

Heels (Female)

- In paletot and gray skirts, females may wear heels with skin tone nylons.
- Pumps must be of a commercial design in fine grain leather, poromeric, or patent leather. Suede pumps are not authorized.
- They shall be untrimmed, with a closed toe and heel. The heel must be at least 1/2 inch, but no more than 3 inches. The sole thickness will not exceed 1/2 inch.

NOTE: Females may purchase their own black pumps as long as they adhere to these regulations.

Heel Taps

Are only to be worn by selected members of the Cadet Regiment:

- Color Guard, Gregory Guard, Signal Corps to practices, performances, and formal cadet occasions.
- Regimental Cadre are not authorized to wear heel taps.
- Taps will never be worn to class or to ROTC departments. ROTCs may have specific guidelines regarding the wear of taps at ROTC specific functions.

COLD WEATHER & OUTER GEAR

Windbreaker(s)

- Authorized to be worn with Hokie Bag and the summer/winter service uniforms only.
- Will be clean and neatly pressed when worn.
- Cadet rank will be worn on the epaulets.
- The sleeves will end within 1-inch of the wrist. The sleeves will at no time cover the hands.
- Will be zipped all the way up at all times, with two exceptions:
 - When the tie is worn, the zipper may be unzipped to rest just below the knot of the tie.
 - When a cadet is seated, the zipper may be unzipped a ¼ of the windbreaker length.
- May be neatly folded and carried but will not obstruct saluting.
- Bulky items will not be placed in the pockets (including hands).

Regimental Band Sweater

- Seniors in the Regimental Band may wear the HT Sweater instead of windbreaker.
- Authorized for formation and when wearing Hokie Bag.
- The sweater will be buttoned all the way.
- The necktie will always be worn with the HT sweater in the winter service uniform.
 - When the sweater and tie are worn together the tie will not be tucked.

Fleece Jacket

- Cadets must wear VTCC issued black fleece on Corps formation days
 - Army and Air Force outer gear are not authorized in VTCC Uniform
- Only authorized to be worn with OCPs or under the parka shell unless extenuating circumstances permit otherwise.
- Will be clean and free of loose strings.
- Cadet Rank will be worn above the nametape.
- Will be zipped ³/₄ of the way up, with the OCP undershirt showing and collar neatly folded down.
- At no time may a cadet put their hands in the pockets of the fleece jacket.
- The sleeves will at no time cover the hands.

Parka (Black All-Weather Jacket)

- Authorized for wear with all cadet uniforms except Paletot.
- Each uniform's designated cover may be worn with the Parka (i.e. Wheel Cover when wearing service uniforms).
- If the Wheel Cover and Parka are the designated uniform while raining, the Wheel Cover Rain Guard will be worn over the Wheel Cover at formation.
- The hood will remain down at formations unless designated by the Regimental Commander.
 - If not in formation, the hood may be worn up, with a watch cap, at the individual cadet's discretion.
- May be used in civilian attire without patches.

Overcoat (Cape)

- Authorized for wear with
 - o Dress A
 - o Dress B
 - Dress C (i.e., special guard duties and Highty-Tighty events only)
 - Mess dress/paletot
 - Seasonal service uniforms.
- Service (wheel) cover will be worn with the overcoat.
- All buttons must be buttoned, with the collar clasped at the top.
- When on guard or in formation the cape portion of the overcoat will be worn flared, utilizing a safety pin that is covered in the back.
- When worn to classes the cape portion will not be flared.
- The collar, when folded down, will be worn over any portion of the cape it touches.

• Crossbelts may be worn over the overcoat as Dress C for special guard duties and for Regimental Band activities. Otherwise, cross belts are not authorized for wear over the overcoat

Trench Coat

- The Trench Coat has been replaced with the Parka as the VTCC Rain Gear. Cadets who have been issued the Trench Coat may wear it when not in formation and following these standards:
 - May be worn in cases of heavy precipitation, with or without the liner.
 - Will be worn buttoned, except for the neck closure, which may be opened or closed. When it is open, it must be buttoned back on the same side of the jacket.
 - The coat is authorized for wear with the service, service dress, and OCP uniform.
 - Cadet rank will be worn on the epaulets.

NOTE: All appropriate uniform accouterments (i.e. nametapes, patches, ranks, etc.) will be worn under cold weather gear and will not be transferred over when cold weather gear is taken off.

UNIT ITEMS

Guidelines

Unit uniform items must be approved through their cadet Chain of Command, the Regimental Commander, the Primary Comm Staff advisor, with final approval by the Commandant.

NOTE: All unit uniform components shall be in good taste, reflect good credit upon the Corps, adhere to all branding regulations, and not portray unprofessionalism.

NOTE: Unit specific uniform items may be worn with civilian attire.

Specific Components

T-Shirts

• Crew neck style

Sweatshirts

Hooded or Crew Neck Style

Ballcaps

- Units may propose and purchase a baseball-like cap to be worn with the Hokie Bag. The process will be the same as proposing a unit item.
- The cap shall be a conventional baseball cap style
- May have adjustable hat band
- May have a mesh back section
- Correct Wear
 - Wear squarely on the head, with bottom edge parallel to and 1-1/2 inch above the eyebrows. Center insignia 1-1/4 inches from the visor.

CHAPTER 3: SPECIFIC COMPONENTS

SUMMER/WINTER DRESS

Summer/Winter Dress A Components

- White/Blue service cover
- Blue blouse
- White/gray trousers
- White gloves (unless designated as inclement weather by the Regimental CO in which black gloves will be worn)
- Black low quarter shoes with black sock
- White cross belts with chest brass (non-officers) / OG wrap with saber (officers).
 - o On certain prescribed occasions, all seniors will wear OD wrap.

NOTE: The components of Winter Dress A are equivalent to Summer Dress A but gray trousers and the blue service cover will be worn.

NOTE: All senior cadets will wear summer Cadet Officer Dress A for change of command Pass in Review.

Summer/Winter Dress B Components

- White/ Blue service cover
- Blue blouse
- White/Gray trousers
- Black low quarters shoes with black socks

Summer Dress B



NOTE: The components of Winter Dress B are equivalent to Summer Dress B but gray trousers and the blue service cover will be worn.

Specifications

- The rank of the individual will be worn on the upper portion of the sleeves of the blouse with the exception of the Cadet Private First Class, Cadet Corporal, Cadet Artillery Corporal, Cadet Ordinance Corporal, Cadet Signal Corporal, and Cadet Color Corporal Ranks, which are worn on the lower portion of the sleeves.
- A white collar will be worn underneath the blouse and will extend 1/8 inch beyond the collar. The collar will be clean and starched when worn.
- Underclassmen will wear the ROTC insignia headlight on the right side, from the wearer's perspective, of the black collar. It will be placed 1 1/2 inches from the front vertical edge of the black collar, and centered 1 inch up from the bottom of the black collar, as seen while looking at the collar.
- Citizen-Leader Track cadets wear a crossed cannon disk for both headlights.

- The round brass VPI insignia, with rifles, wings, an anchor, or cannons will be worn on the left side of the collar, from the wearer's perspective.
- Cadet officers will wear the brass "VPI" in place of the ROTC insignia headlight.
- Cadet officers will wear their service insignia or crossed sabers for Citizen-Leader Track in place of the VPI headlight.





Cadet Officer Collar

Non-Officer Cadet Collar

NOTE: At any public forum (e.g., football games), the blouse shall remain zipped at all times and ONLY while seated may it be unzipped a ¼ of the length of the blouse and the collar unclasped.

Cross Belts

- When worn, the belt from the right shoulder to the left hip is put on first, followed by the left shoulder to the right hip belt.
- The brass chest brass will be put on in the same direction as the first belt, approximately halfway between the bottom of the collar and the top of the belt buckle.
- There will be a two-finger separation between the edge of the belt closest to the collar and the collar of the blouse along the line of the shoulder.
- Belts will meet at the hips forming a "V".
- When worn with the cape:
 - The belt should be worn in a similar manner. The chest brass will be located between the second and third buttons. The buckle will be between the fourth and fifth buttons.

OG/OD Wrap

- When worn by cadet officers they will carry a cadet saber.
- Only one cross belt is worn from right shoulder to left hip.
- The chest brass is placed on the cross belt so that it is centered on the chest measured four finger widths below the collar.
- The tassels shall hang down on the side of the left leg with the ends between the knees and the ankles.
- The tassels will be worn so that the square of the stitching is not visible. The cross belt will not be allowed to hang loose from the chest or back.

- The waist part of the maroon wrap will also be worn tightly and will completely cover the white belt of the cross belts.
- Cadets without wrap will wear cross belts.
- Wrap may be worn without sabre (as sabre supplies dictate).
- When OD wrap is prescribed, cadets will wear the entire maroon wrap over the blouse.
- A saber will be carried by cadet officers when wearing OD wrap.
- The baldric is worn over the right shoulder to the left hip.
 - The ends of the baldric should meet and cross on the left hip and be tucked tightly into the black cadet belt.
- The black cadet belt should be worn as a saber belt.
- The maroon waist wrap and tassel portion shall be worn in the same manner as for OG wrap, described earlier.

Sanitized Dress A/ Dress B

- Only Collar insignia will be worn
 - No ribbons, pins, cords, or other accoutrement are authorized

NOTE: At no time will any cadet wear a backpack or carry any straps over the shoulder in the Dress A or B uniform.

NOTE: Eating in Dress A & B is authorized upon removal of white gloves

SUMMER/WINTER SERVICE UNIFORM

Summer Service (White Shirt) Components

- Blue service cover
- White shirt
- Black belt / White web belt
- Gray trousers
- Gray skirt optional for female cadets
- Black low quarter shoes with black socks
 - o Black pumps with nylons when worn with skirt

Winter Service (Gray Bag) Components

- Blue service cover
- Gray Shirt
- Black Tie / Tie Tab
- Black Belt / White web belt
- Gray trousers
- Gray skirt optional for female cadets
- Black low quarter shoes with black socks
 - Black pumps with nylons when worn with skirt

NOTE: Senior White Shirt will include collar insignia. Chinstrap will be gold instead of black.

NOTE: Underclassmen Gray Bag will exclude collar insignia. Chinstrap will be black instead of gold. Necktie will be tucked in.

Specifications

- The name tag will be worn on the right hand pocket flap, with its top edge along on the second seam of the pocket, and centered on the pocket flap button.
- Company pins will be worn on the left pocket flap.
- Shirts will be worn with a proper military tuck.
 - Shirt stays must be worn at all times to ensure the proper military tuck stays at all times
- Pleats will be neatly made and located on the sides of the shirt.
- At no time will any part of the shirt hang over the belt.
- All buttons must be buttoned and removed of loose strings.
- Creases on the sleeves of service uniforms will start at the back edge of the epaulet and go down the entire sleeve in a neat line. For the winter service uniform, the crease will connect with the pleat at the cuff.
 - There will only be one crease on the sleeves and trousers, no "railroad tracks" may be displayed and must be ironed out.
- Collars will remain starched, pressed, and free of stains.
- The black tie will not show past the collar in the back.

NOTE: No shirt tuck or tailoring should be so tight as to restrict normal, natural movement or comfort, or create the appearance of being skin-tight.

NOTE: All items shall be kept clean, free of stains, pressed, and free of odor.

- A white V-neck T-shirt must be worn under white shirt and must not be visible.
 - Crew neck, A-shirts, or any other type of undershirt will not be worn under the Summer Service white shirt.
- Cadets may wear an appropriate civilian or Corps related shirt underneath the long sleeve Winter Service gray bag uniform, so long as it is not visible.
- Cadets will have a straight "gig line."
 - The male gig line is made straight by keeping the shirt edge (along the button line) in line with the edge of the zipper flap.
 - Females will keep the shirt edge in line with the seam of the zipper flap.
 - The edge of the "P" closest to the "V" on the black leather belt is in line with the buttons, which is different for males and females.
 - First-year cadets will have their buckles centered on the buttons of the shirt.
- Ribbons, badges, cords and any other accessories will be worn in accordance with these regulations.

- Cadet officers will wear:
 - VPI insignia on the right collar and the cadet's ROTC/Citizen-Leader Track (crossed sabers) on the left collar.
 - The "VPI" will be placed 1-1/2 inches from the corner tip of the right collar along a centered diagonal angle (45 degrees) with the "bottom" of the insignia facing out towards the cadet's right foot.
 - The Army, Air Force, Navy, Marine Corps, and Citizen-Leader Track insignias will be placed 1-1/2 inches from the corner tip of the left collar along a centered diagonal angle (45 degrees) with the bottom of the insignia facing out towards the cadet's left foot.
 - Army Seniors are authorized to wear their Branch Insignia in place of the Army ROTC collar device

OPERATIONAL CAMOUFLAGE PATTERN (OCP)

Operational Uniform Components

- OCP Patrol Cover
- OCP Blouse
- Coyote or Tan Corps Crest Undershirt
- OCP Trousers
- OCP or issued rigger belt
- Olive drab, coyote, or black boot socks
- Coyote Combat Boots

Specifications

- Nametapes shall adhere to the following:
 - Will be worn with VTCC OCPs.
 - Will be worn in an identical fashion to the service uniform.
- The VTCC unit identifier will be worn centered above and along the top edge of the left shirt pocket.

NOTE: Ribbons are not authorized to be worn with OCPs.

• Shirt and Trousers do not have to be creased and pressed.

NOTE: <u>ALL</u> pockets shall be secured (i.e., buttoned, velcroed) when not in use.

- Trousers shall adhere to the following:
 - Will fit the wearer, with enough space to allow squatting and bending.
 - May be bloused over or tucked into the boots, not exceeding the third eyelet of the boots.
- The belt shall adhere to the following:
 - Will be worn with the belt end tab extending just past the buckle not to exceed three inches.
 - Excess belt length shall be cut or worn between the belt and the trousers.
 - The tab will be worn on the left side of the wearer's buckle with the buckles leading edge flush with the fly seam of the pants.
- Boots shall adhere to the following:
 - Kept neat and free of stains (i.e., food, grass, mud)

NOTE: Unserviceable boots shall be taken to the tailor shop for replacement.


Proper Wear of VTCC Patches & Tabs

- Patches must be centered straight, with applicable velcro tabs centered above said patches.
- Velcro strips above the shoulder pocket must be forward and folded so that the black square is covered and the velcro is not exposed.

Tabs

Tabs shall adhere to the following:

- Only two upper tabs and one lower tab are authorized to be worn at a time.
- Only those tabs listed in the appendices are authorized to be worn.
- Not detract from the smartness of the uniform
- Curved Tabs shall be adjacent to the corps patch. All other upper tabs will be placed above.



New tab Review & Approval

Any new tab ideas must be approved by the Commandant of the Corps after a thorough review by the unit (i.e, company, organization) chain of command has reviewed the purpose, color scheme, and cost.

Rolled Sleeves

- When approved by the Regimental Commander via Regimental Order (UOD) or any Commander via OPORD (Special Event), cadets are authorized to wear sleeves rolled up consistent with US Army procedures and shall be:
 - o Rolled with the camo facing out.
 - o Rolled neatly above the elbow but no more than 3 inches above the elbow.
- An expectation is when a cadet is wearing OCPs and long sleeves are NOT rolled in order to provide protection.

MODIFIED OCPS (MODS)

When prescribed by the unit Commander, Officer in Charge, or senior member all Cadets shall follow the guidelines below:

MODS Components

- All standard OCP components
- Unit t-shirts (optional)
- Unit sweatshirts (optional)

NOTE: All organizational units shall follow the guidelines for MODS found in the *Organizational Uniform Modification* section of this instruction.

MODS Manner of Wear

- MODs will be worn the same as OCPs with the removal of the OCP blouse. Unit t-shirts and sweatshirts may be worn when authorized in accordance with the unit component guidelines.
- Trousers will be bloused at all times. Trousers may be unbloused when actively performing physical training, and shall be re-bloused when complete.

PALETOT MESS DRESS

When designated as the uniform for a Corps event, all cadets will wear the formal dress (Paletot) uniform. An exception will be to the Senior Banquet if a non-senior cadet is attending as a date.

Other exceptions will require approval by the Regimental Commander after coordination with the Commandant of Cadets.

General Specifications

- No cover is authorized for wear with Paletot.
- Female cadets will wear their hair in a bun or ponytail in accordance with grooming standards.
- Paletot is worn with shined brass cadet buttons or anodized service buttons. Pocket buttons on the Paletot shall have their fasteners taped up inside so as not to be seen.
- Collar fasteners on the Paletot will be clasped at all times. Female shirt collar buttons and neckties will remain buttoned and tied unless authorized by the chain of command.
- Cadet shoulder boards (with appropriate class/year) issued or bought through the Tailor Shop will be worn with Paletot. Cadets are not authorized to substitute ROTC shoulder boards or make their own.
- Male seniors will wear brass "VPI" insignia and the cadet's ROTC or Citizen-Leader Track insignia on their collars, the same as on blue blouses.
- Female seniors will wear brass "VPI" insignia and the cadet's ROTC or Citizen-Leader Track insignia centered horizontally 1 inch from the bottom of the collar of the formal mess jacket.
- Cords, ribbons, pins, and badges will be worn in accordance with these regulations.
- OD wrap and saber are authorized for wear with the Paletot uniform.

Male Components

- Paletot blouse
- White trousers
- Black low quarter shoes and black socks

Female Components

- Paletot blouse
- White pleated dress shirt with black studs
- Neck tab
- White skirt with skin tone nylons or white pants
- Gold cummerbund
- Black pumps (with 1 1/2 to 2 ½ inch heel).

HOKIE BAG Mandatory Items

- Maroon VTCC issued polo style shirt and shall adhere to the following:
 - Must be tucked into the pants at all times

NOTE: Undershirts are optional and if worn the undershirt shall not be visible

- Khaki pants and shall adhere to the following:
 - Must fit the wearer comfortably and modestly without excessive tightness or baggage.
 - Cold weather gear may be worn at the cadets discretion unless specified by the Regimental Commander.
- Black/brown belt and shall adhere to the following:
 - Plain with no visible designs, logos, studs, or markings
 - No holes that denote damage on them.
 - Buckles shall be business casual.
- Black/brown shoes
 - o Color must match belt color
 - Closed toed
 - Professional/dress (i.e., oxford style, sperry style, boot style)
 - Socks must be conservative in color (i.e., black, gray, brown) with no visible designs or logos.

Optional Items

- Ball caps
 - The wear of gifted Alumni baseball caps is permitted with the wear of Hokie Bag.

VICTORY BAG

- Freshmen (FR): Hokie Bag.
- Upperclassmen (UC): Victory Bag
 - If UC did not previously wear Hokie Bag correctly, they will wear Hokie Bag until approved for the victory bag privilege by their unit commander.
- UC that do not have Hokie Bag will be in Dress B

Mandatory Items

- Shirts:
 - Must be Hokie spirit wear
 - Must be officially licensed Hokie or VTCC merchandise may be stripped/patterned but must be associated with Virginia Tech.
 - The predominant color may be determined by the Regimental Commander
 - Must cover the midriff and shoulders.
 - No explicit or inappropriate language or references.
 - T-shirt, polo, quarter-zip, or button-down styles only.
 - Long-sleeve versions of the styles listed above are authorized
- Pants:
 - Jeans (solid blue, no rips or holes) or khakis allowed per Denim Day and Hokie Bag guidelines.
- Shoes:
 - Black or brown dress shoes (boots allowed) or white sneakers.
- Hair/Hygiene:
 - Males must maintain a clean shave and hair standards as seen in VTCCINST670-1: Chapter 5: Grooming Standards

• Females must follow PT hair standards as seen in VTCCINST670-1: Chapter 5: Grooming Standards, page 44

Optional Items

- Headgear:
 - Victory Bag participants: May wear conservative Hokie spirit baseball caps. Must be worn bill-forward.
 - Headgear may only be worn after formation
 - o In inclement weather, watch caps may be worn in accordance with these regs
- Cold Weather Gear
 - In inclement weather, tailor-shop issued black VTCC PT crewneck, VTCC approved company, battalion or regimental merchandise, and any Virginia Tech licensed hoodie, crew neck or quarter zip may be worn as outerwear
 - o Parka may be worn in Victory Bag
 - Exceptions:
- Upperclassmen not wishing to participate in Victory Bag may wear Hokie Bag.
- Cadets on military probation will not have the Victory Bag privilege until their military probation has ended.
- This privilege may be removed at the unit commander's discretion due to disciplinary issues and reverted to Hokie Bag UOD.

PT GEAR

NOTE: During the period of sundown to sunrise a reflective (i.e., glow) belt **shall** be worn during PT at all times.

The Corps of Cadets Physical Fitness Uniform will consist of the following:

- Black VTCC PT shirt, black VTCC PT shorts, and athletic shoes with white or black socks (ankle or calf-length).
- The PT Shirt must be neatly tucked into the PT Shorts.
- The VTCC PT Sweatshirt and Sweatpants are to be worn at the individual cadets discretion.
 - The PT shirt is to be worn underneath the sweatshirt.
 - o PT shorts underneath the sweatpants, when actively engaged in physical activity.
- Only be worn to class if authorized by the chain of command and granted written approval.
- Civilian PT attire is authorized for personal PT after a cadet's freshman year red phase.
- PT gear is authorized for food pick up (no dining in) under the following exceptions:
 - Air Force and Navy ROTC cadets, directly after morning PT.
 - Regimental Band cadets after evening field practice.
 - o Directly following a personal workout, as directed by the Regimental CO.

MISCELLANEOUS

Policy

• Cadets will not walk while engaged in activities that would interfere with the hand salute and greeting of the day or detract from a professional image. This includes but is not limited to texting, eating, or chewing gum while walking in uniform.

- Cadets may stop walking and step to the side to engage in these activities if needed. Taking a phone call is permitted as long as cadets are aware of their surroundings.
- Public Displays of Affection (PDA) are considered unprofessional and are not permitted while in uniform.
- When seated outside while eating, covers may be removed.

Reduction to Cadet Private

- Cadets reduced to the rank of Cadet Private forfeit all uniform privileges and will return to non cadet officer standards for all uniforms.
 - o i.e., cadet officers reduced to Cadet Private will no longer wear gold chin straps, collar devices, or have the black tie untucked.

ROTC Uniform

- During the Fall semester, Cadets may switch to ROTC/Citizen-Leader uniform after 1400 hours for their respective ROTC/Citizen-Leader Track labs.
- During the Spring semester, the Regimental Commander may designate the entire day for wear of the ROTC/Citizen-Leader UOD.

CHAPTER 4: UNIFORM MODIFICATIONS

UOD EXEMPTIONS

• Any cadet unable to wear any Corps uniform for any reason, shall request permission via the chain of command. Some classes are recognized as having adverse conditions that may damage the cadet uniform (i.e. laboratories, field work, etc.). In these cases, a request form shall be submitted through the chain of command explaining the reason for the wear of OCPs.

NOTE: Individual cadets shall not assume UOD Exemptions are approved until the general request has been returned.

NOTE: All approved exemption general request forms shall be carried with the Cadet during normal business hours.

PARTIAL UNIFORM COMPONENTS

Policy

- Partial uniform is authorized for wear in the cadet barracks with the following exceptions:
 - o Partial uniform will not be worn in the lobby or Commandant's Staff Hallways.
 - Partial uniform will not be worn when conducting official business to include inspections within the cadet barracks and during New Cadet training.
- Sophomore, junior, and senior cadets may wear appropriate partial uniforms while inside the residence halls.
- First-year cadets are authorized to wear partial uniforms inside their rooms. Opening the door of the room does not negate this authorization.
- Sophomore, junior, and senior cadets may wear civilian clothes inside the barracks as a privilege prescribed by the Regimental Commander.

Summer/Winter Dress

- The blouse may be removed but the underlying T-shirt must be tucked into the trousers.
- An OCP web belt will be worn with trousers.
- Black low quarter shoes will be worn.

Summer/Winter Service

- The shirt may be removed but the white V-neck must be tucked into the trousers/skirt.
- The black belt will be worn with the trousers.
- Cadets may wear an appropriate civilian or Corps related shirt underneath the long sleeve winter service uniform.
- Black low quarter shoes will be worn.

OCPs

- The blouse may be removed, but all other items must be worn.
- No other items are ever authorized for wear in OCPs.
- Authorized boots must be worn at all times.

NOTE: Cadets must be in the <u>proper</u> uniform of the day (UOD) when they leave their building, even if it is to travel to another building on Upper Quad.

ORGANIZATIONAL UNIFORMS GUIDELINES

Unit Specific Guidelines

The unit Commander/OIC is responsible for coordinating any unit specific components with the Deputy Commandant or Comm. Staff Advisor for authorization. Without authorization all units shall adhere to uniform guidelines found in this document.

Operational Organizational Uniform Specifications

The following organizations are authorized to make modifications to the uniforms outlined below when performing organizationally assigned duties.

Color Guard

Grey Bag

- Short sleeve gray bag shirt with white v-neck
- No name tapes or pins
- No black tie
- White chin strap

Dress A/B

- White pants with blue wheel cover
- White chin strap
- White wrist cuffs

Conrad Cavalry

Dress B (any combination of)

- Stetson
- Gray trousers with yellow stripe
- Riding boots

Gregory Guard

Gray Bag

- Short sleeve gray shirt with white crew neck
- No black necktie
- Ranks and name tape only

Pipes and Drums

Dress B

- "Piper Bag"
 - o Balmoral Beret
 - o Kilt w/ black UC belt and sporran
 - Spats (white boot covers)
 - o Kilt hose and flashes
 - o Pipes and Drums Cord
- "Modified Kilt"
 - o Kilt with combat boots and green socks
 - o Pipe and Drum shirt

Skipper Crew

Dress B

- Red chin strap on blue wheel cover
- Gray trousers with red stripe
- Black combat boots (optional)
- No company pin
- Red Skipper Crew Cord

CHAPTER 5: GROOMING STANDARDS

PURPOSE

A cadet's appearance leaves a lasting impression. Accordingly, it is imperative that a cadet look sharp and presentable at all times. The purpose of this regulation is to define the grooming standards for all cadets. As a Senior Military College, under Title X, we are required to meet certain DoD standards that are in conformity with US military standards.

Each Senior ROTC program has service-directed grooming standards. These may differ, slightly, between each Service. The purpose of having Corps Grooming standards is to facilitate achieving uniformity across the entire Corps, to include those cadets in the VPI / Citizen-Leader track program. The vast majority of the standards described in this section flow directly from DoD guidelines.

POLICY

Cadets are required to abide by these regulations during the academic year when in uniform. Cadets must also abide by selected regulations when out of uniform. Just as in the military Services, compliance may result in cadets updating their hairstyle when directed to by the chain of command, should the hairstyle present an unprofessional image in the judgment of the Corps or ROTC programs.


GENERAL

- May not be styled with designs, sharply curved lines, or zigzag lines.
- May not be unconventional and will present a conservative, professional appearance.
 Unconventional and exaggerated styles, to include shaved portions of the scalp other than the neckline, designs cut in the hair, hair sculpting (eccentric texture or directional flow of any hairstyle to include spiking), hairstyles with severe angles or designs, and unbalanced or lopsided hairstyles are prohibited.
- Dyes, tints, or bleaches must result in natural hair colors and a natural appearance.
- Bulk or length may not interfere with the normal wear of headgear.

MALE HAIR

- Hair on top of the head will be neatly groomed. The length and bulk of the hair may not exceed 3 Inches (i.e., length of Hokie Passport) and must present a neat and conservative appearance.
- The hair must present a tapered appearance.
 - A tapered appearance is one where the outline of the cadet's hair conforms to the shape of the head, curving inward to the natural termination point at the base of the neck.
- When the hair is combed, it will not fall over the ears or eyebrows or touch the collar.
- The block-cut fullness in the back is permitted to a moderate degree, but shall maintain a tapered appearance.
- Unauthorized hair items or styles:
 - o Braids, cornrows, twists, or locks.
 - A single, untapered patch of hair on the top of the head (not consistent with natural hair loss).
- Completely shaved or trimmed closely to the scalp is authorized.

- Hair that does not part naturally may cut a part into the hair or style the hair with one part.
 - The part will be one straight line, not slanted or curved, and will fall in the area where the cadet would normally part the hair.
- Sideburns shall adhere to the following:
 - Be neatly trimmed.
 - Be a clean-shaven line.
 - Will not extend below the bottom of the exterior ear opening.
 - Will not be styled to taper, flair, or come to a point.
- Wigs & hairpieces shall adhere to the following:
 - Males are prohibited from wearing wigs or hairpieces while in uniform, or in civilian clothes on duty, except to cover natural baldness or physical disfigurement caused by accident or medical procedure.
 - Will conform to the standard haircut criteria, as stated in this regulation.



General Example of Male Hair Standards

Facial Hair

- Facial hair shall adhere to the following:
 - o Mustaches, goatees, and beards are not permitted.
 - o All cadets shall be clean-shaven at all times in & out of uniform.

Special Accommodations & Waivers

- Religious accommodations waivers for facial shall adhere to the following:
 - Religious accommodation waivers shall be approved via General Request form by the unit Deputy Commandant.
 - o Approved facial hair must be worn in a neat and conservative manner.
 - Beards shall not exceed 2 inches in length.
 - Must be rolled, tied and/or otherwise groomed to achieve a length not to exceed 2 inches when measured from the bottom of the chin.

NOTE: Permanent shaving waivers are <u>not</u> authorized.

NOTE: Any cadet granted a shaving waiver <u>shall</u> retain a copy of the approved waiver on their person at all times in uniform.

- Pseudofolliculitis Barbae (PFB) or other medical condition shaving waivers shall adhere to the following:
 - Medical shaving waivers shall be approved via General Request form by the unit Deputy Commandant and must be accompanied by proper documentation from a health care provider.
 - The Deputy Commandant may direct re-evaluation if the prescribed regimen is being violated.
 - Cadets shall request a waiver at the beginning of each academic year (AY).
 - o If a shaving regimen or waiver is authorized, facial hair shall:
 - Be properly groomed (i.e., clean and combed or brushed).
 - <u>Not</u> exceed 1/4 inch in length unless expressly granted per the medical accommodation waiver.
 - The outer edges of the beard on the face or neck area may be optionally outlined/edged.
 - Outlining, edging or shaping the beard is defined as light clipping or trimming of hair at the very outer edges of the beard to give a shaped appearance.
 - If outlining results in skin irritation discontinue edging the beard.
 - Unit supervisors will actively monitor and ensure the PFB treatment regimen is followed.


NOTE: Cadets are responsible to ask questions when in doubt of any requirements or directives.

FEMALE HAIR

- First-year cadet females shall keep hair above the collar in all uniforms until designated by the Regimental Chain of Command (CoC).
- Female hairstyles are organized into three basic categories:
 - Short length
 - Medium length
 - Long length
- When worn "up", will not extend below the bottom of the uniform collar
- Will be gelled down or pinned back to avoid excessive flyaways.
- Hair styles or devices will not interfere with proper wear of cadet headgear.
- Bangs, if worn, may not fall below the eyebrows, may not interfere with the wear of all headgear, must lie neatly against the head, and not be visible underneath the front of the headgear.
 - The width may extend to the hairline at the temple.
- The bathrobe is not considered a uniform, therefore hair may be worn loose and down throughout the hygiene process, this includes all freshmen cadets as well.

Short Length


• Length that extends no more than 1 inches from the scalp

Medium Length


- Length that does not extend beyond the lower edge of the collar and extends more than 4 inches from the scalp.
- Layered and graduated hairstyles are authorized, so long as each hair's length, as measured from the scalp to the hair's end, is generally the same length, not exceeding an 1 inch difference in length, giving a tapered appearance.




General Example of Medium Length

Long Length

- Length that extends beyond the lower edge of the collar.
- Will be neatly worn in either a bun, single ponytail, two braids or a single braid so as not to fall below the bottom of the shoulder blade.

Specific Female Hair Items

Devices

- Hair holding devices are authorized only for the purpose of securing the hair, not for decoration.
 - Hair bands/devices will be the same color as the hair or black.
- Such devices should conform to the natural shape of the head.
- Devices that are conspicuous, excessive, or decorative are prohibited.
- Prohibited devices include, but are not limited to the following:
 - o large, lacy scrunchies; beads, bows, or claw or alligator clips; clips, pins, or barrettes with butterflies, flowers, sparkles, gems, or similar designs, or scalloped edges; and bows made from hairpieces.
- Foreign Material is defined as beads or decorative items and is not authorized at any time.

Braids, Cornrows, Twists, & Locks

- Medium and long hair may be styled with ponytails, braids, cornrows, twists, or locks using the following:
 - Have a diameter no greater than 2 inches.
 - Present a neat, professional, and well-groomed appearance.
 - Spacing between the braids, cornrows, twists, or locks must be uniform without designs.
 - May be worn against the scalp or loose (free hanging).
 - When worn loose, such hairstyles must be worn per medium hair length guidelines or secured to the head centered on the back of the head.
 - Ends must be secured inconspicuously.
- The individual is expected to contain multiple braids, cornrows, twists, or locks in a tasteful bun and wrap the hair until there is no hair straying.
- When not worn loosely and instead worn close to the scalp, they must stop at one consistent location of the head and must follow the natural direction of the hair when worn back.
- Braids, cornrows, twists, or locks that distinctly protrude (up or out) from the head are not authorized.

Multiple Styles

- Female cadets are authorized to wear multiple hairstyles at once as long as it is neat in appearance.
- Two braids will be evenly spaced from the center and the shoulders.

Ponytails

- Ponytails and single braids must be worn centered behind the neck and remain free of loose strands.
 - The hairstyle must maintain a neat and secured appearance.
- Ponytails will start on the back of the head, never the top of the head.
- If wearing a company cap, then a ponytail may be worn through the hole in the back of the cap.

Hair Extensions

• Hair extensions are authorized. Extensions must have the same general appearance as the individual's natural hair and otherwise conform to this regulation.

Wigs

• Wigs, if worn, must look natural and conform to regulations. Wigs are not authorized to cover up unauthorized hairstyles.

Physical Training

- Long length hair may be worn in a ponytail during physical training. A single ponytail centered on the back of the head is authorized in physical fitness uniforms only when within the scope of physical training, except when considered a safety hazard. The ponytail is not required to be worn above the collar.
- Hairstyles otherwise authorized in this chapter (such as braids, twists, and locks) may also be worn in a ponytail during physical training.

Hairnets

• A full hairnet will not be worn unless it is required for health or safety reasons. A hairnet that covers just a bun is permitted providing they are of natural color similar to the cadet's own. Hair Nets are suggested for textured hair to prevent any stray hairs and braids from protruding from the bun.

Headbands

• Headbands shall be used only as a last resort, and will be cloth, 1/2 inch or less, and must be a human hair color close to the cadet's natural color, and not present an extreme appearance.

Buns

• The bun shall be as concise and tasteful as possible. It will not exceed 3.5 inches in bulk and the width shall be no wider than the width of the head.

Other General Appearance Items

Cosmetics

- Extravagant cosmetic styles and colors, to include makeup designed to cover tattoos, are inappropriate with the uniform and are prohibited. Permanent makeup, such as eyebrow or eyeliner, is authorized as long as the makeup conforms to the standards outlined above.
- Eyelash extensions are authorized but must not exceed 0.5 inches and must be natural in color.
- Males are prohibited from wearing cosmetics, except when medically prescribed.
- Females are authorized to wear cosmetics with all uniforms.
- Females will not wear shades of lipstick or nail polish that are extreme, that detract from the uniform.
 - Extreme colors include, but are not limited to purple, gold, blue, black, white, hot pink, bright red (i.e., fire engine), green, yellow, and fluorescent/neon colors.

Fingernails

- All personnel will keep fingernails clean and neatly trimmed so as to not interfere with performance of duty, detract from the military image, or present a safety hazard.
- Females fingernails shall not exceed a nail length of 1/4 inch as measured from the tip of the finger.
- Females may use neutral and color nail polish that does not detract from the uniform.
- Females are permitted to have French tips and American manicures.
- Males fingernails shall not extend beyond the fingertip.
- Males are authorized to wear clear nail polish.

Piercings

- Males are not permitted to wear earrings or other body piercings when in uniform.
- Earrings must be 1/4 of an inch in diameter or smaller, and must have gold, silver, pearl or diamond-type.
- Only one earring per ear is authorized.
- Earrings may be worn in OCPs unless in a tactical setting.
- Other body piercings are not permitted if they will be visible in military uniforms.

TATTOOS

Any tattoos obtained after joining the Corps must, at a minimum, conform to Service/ROTC policies for those cadets enrolled in ROTC programs. It is still the desire that any cadet, obtaining a tattoo after joining the Corps, should ensure that the tattoo is not above the neck, on the face nor hands with the exception being a tattooed ring on the ring finger.

CHAPTER 6: RIBBONS, CORDS, MEDALS, & PINS

General: A long-standing tradition in the military has been the recognition of individual accomplishments, membership in special and/or unique units and organizations, and distinguishing special abilities and actions. This is done through the displaying of cords, ribbons, and badges on the uniform. In addition is the long-standing tradition of Virginia Tech students wearing organizational pins to show pride and *esprit de corps* for involvement in organizations open to all Virginia Tech students. The purpose of this section is to define the guidelines for acceptable wear of cords, ribbons, and badges while a member of the Corps of Cadets.

NOTE: The Regimental Commander may authorize pins throughout the year utilizing standing orders or memorandum for the record (see VTCCINST. 1872.1).

RIBBONS

- Wear of dilapidated ribbons is unauthorized.
- Wearing of any ribbon not rightfully earned is unauthorized.
- Cadets shall wear a minimum of the three highest earned ribbons (see Annex A).
 - If a cadet has not earned three ribbons, they will wear the maximum number they have earned.
- No more than 3 ribbons are worn in a row.
- When wearing multiple ribbon bars:
 - Stacked ribbon bars shall be placed together with no gaps between bars
 - If the top bar has 3 ribbons, it will be worn flush with the bar below it.
 - If the top bar has 2 ribbons, the seam between the top 2 ribbons will be centered on the middle ribbon of the bar below.
 - If the top bar has 1 ribbon, it will be centered on the middle ribbon of the bar below.
- Ribbons will be worn in order of importance, with the most important being to the top
 and left and the least important being to the bottom and right, as seen while looking at the
 ribbon bars. Ribbons shall be worn in order of importance according to the list and chart
 located in the appendices.
- Organization ribbons shall adhere to the following:
 - Be worn in order of involvement.
 - Ribbons for organizations in which a cadet is an officer shall be placed first.
 - If a cadet serves as an officer in more than one organization and wears a ribbon for each organization, then ribbons shall be placed in order of the importance of the positions, which the cadet holds (i.e. commander, executive officer, secretary, etc.).
- Grade ribbons shall adhere to the following:
 - Be worn for good grades received at Virginia Tech. If a cadet receives consecutive grade ribbons of the same type (e.g. two or more maroon ribbons in a row) then stars will be worn on the ribbon to denote continuous academic achievement.
 - Once a grade ribbon is awarded, its continued wear is authorized, regardless of the cadet's current academic standing.

- Prior service ribbons shall adhere to the following:
 - May be worn in lieu of cadet ribbons, but not worn with them.
 - Will be worn as per the regulations of the specific service awarding them.
- Any cadet ever receiving the Beverly S. Parrish Jr. (Gold Cord) award may wear the corresponding ribbon for as long as they are a cadet.
- Multiple achievement of the same award is denoted through the wear of stars (or palm leaves on selected ROTC awards) on the ribbon of the award received. Stars shall be centered on the ribbons and recognize multiple awards in the following manner:
 - Bronze star one additional award (e.g. second time awarded). Up to four bronze stars may be worn on a ribbon, denoting the receipt of that particular award five times (the ribbons counting as one awarding).
 - Silver Star five additional awards (e.g. sixth time awarded). Up to five silver stars may be worn on a ribbon. Bronze stars are worn in addition to silver stars to denote awards between each fifth award.
 - Stars may be worn on organization ribbons to denote officer positions or as part of the organization's symbology.

Manner of Wear

Dress A/B

- It is the intent that <u>all earned</u> ribbons will be worn on the Dress A/B and Paletot uniform.
- In Dress A/B, ribbons shall adhere to the following:
 - Be worn in order of precedence from the wearer's right to left in one or more rows with no space between rows.
 - The first row of ribbons is positioned ½ inch above the company pin. The left side of the ribbon rack shall be flush with the left edge of the company pin.
 - If only wearing one ribbon, it shall be placed as if in the middle of a ribbon bar that is flush with the company pin.
 - If only wearing two ribbons, the seam between them shall be placed as if centered on the middle of a triple ribbon bar that is flush with the company pin.

Paletot

- Male Paletot: On the mess jacket, ribbon racks will be worn ½ inch above the left shirt pocket edge and are centered with the flap button.
 - If wearing only 3 ribbons, the row shall be centered on the flap button.
 - If wearing only two ribbons, the seam between the ribbons shall be centered on the flap button.
 - If wearing only one ribbon, it shall be centered on the flap button.
 - If wearing multiple ribbon bars, the bottom row shall be centered on the flap button
- Female Paletot: On the mess jacket, ribbon racks shall be centered horizontally on the left breast of the mess jacket positioned parallel to the ground ¼ inch above the midpoint of the left lapel curve.

Service Dress

- Ribbons will be worn in order of precedence from the wearer's right to left.
- Ribbon racks will be worn ½ inch above the top left shirt pocket edge, and are centered on the flap button.
 - If wearing 3 ribbons, the row shall be centered on the flap button.
 - If wearing two ribbons, the seam between the ribbons shall be centered on the flap button
 - If wearing one ribbon, it shall be centered on the flap button.
 - If wearing multiple ribbon bars, the bottom row shall be centered on the flap button
- No more than 50% of a ribbon may be covered by the shirt lapel.



Uneven Ribbon Combinations

NOTE: The only exception to this is the Regimental Band cord, which is worn in reverse.

Cords

- Prior armed force service cords:
 - May be worn in lieu of cadet cords, but not worn with VTCC issued cords.
 - Such cords will be worn as per the regulations of the specific service awarding them
 - If a cadet elects to wear a cords from prior service, they must also wear only ribbons and pins from prior service.
- Beverly S. Parrish Jr. Award cords:
 - o Only members of the unit receiving the award are authorized to wear the cord.
 - Gold Cords are awarded in the Spring of the academic year (AY).
 - Awardees shall wear their cord from the Spring PIR/CoC to the following Spring.

EXAMPLE: Bravo Co. is awarded Gold cord in SP24. Bravo shall wear their cords from SP24 PIR/CoC to SP25 Corps award ceremony.

- Cadets transferring into or first-year cadets entering that unit are not authorized to wear the award.
- Cadets transferring out are authorized to wear the cord in their new units as defined above.
- Athletics cords:
 - Only cadets who participate in the highest level of their sport are authorized to wear the Athletics cord.
- Inspector General (IG) cords:

• Will be worn in White shirt, Grey bag, Dress A/B, and Paletot uniforms.

MEDALS

- Medals will be worn on the dress and mess uniforms as a substitute to wearing ribbons.
- The amount of medals worn will not be excessive and all medals must be clean, unscratched, and not exhibit dilapidated ribbons.

PINS

All pins shall adhere to the following:

NOTE: Only pins listed in Annex D shall be worn in any uniform.

- A maximum of two pins shall be worn on any uniform.
- Pins will be tasteful, not of excessive size, and related to Corps, ROTC, or military-professional organizations.
- Pins may be worn on the service, dress, and mess uniforms.
- Pins may also be worn on the tassel of the OG/OD wrap.
- All pins awarded by ROTC units will be worn as prescribed by the respective ROTC.

Manner of Wear

Dress A/B

- Pins are placed on the left breast.
- The top of the pins shall be in line with the bottom of the armpit seam and parallel to the deck.
- The company pin shall be placed first (from left to right looking at the blouse), one inch from the black fabric along the zipper line.
- The second pin shall be parallel to and spaced \(\frac{1}{4} \) inch to the right from the first.

Paletot

- On the mess jacket, in the upper left corner of the left pocket, as seen while looking at the pocket:
 - The first pin shall touch the inside vertical (side of pin) and horizontal (top of pin) seams of the pocket flap.
 - The second pin shall be spaced ¼ inch from the first and flush with the horizontal seams of the pocket flap.
 - The more important pin shal be placed first.
- On the sash, the Corps Crest is mandatory and the secondary pin will be optional.
 - May wear a singular company pin from their previous companies.
- Female Paletot: On the mess jacket, pins shall be placed under the ribbon rack, aligned with the left side of the ribbon rack.

Service Dress

- On the upper left corner of the left pocket, as seen while looking at the pocket:
 - The first pin should touch the inside vertical (side of pin) and horizontal (top of pin) seams of the pocket flap.
 - The second pin, if worn, shall be spaced ½ inch from the first and flush with the horizontal seams of the pocket flap.

CHAPTER 7: CIVILIAN ATTIRE

General: Cadets represent the VTCC while in uniform and civilian attire. Therefore while in civilian attire it is each cadet's responsibility to represent the Corps in a positive manner. The purpose of this section is to define the guidelines for acceptable civilian attire while a member of the Corps of Cadets.

POLICY

- Distinctive cadet uniform items (e.g., Corps crest pins, ROTC collar brass, rank) may not be worn with civilian clothing.
- Generic cadet uniform items (e.g., shoes, socks, gloves, scarves, black belt, sweater) may be worn with civilian clothing.
- Appropriate formal attire (coat and tie) will be worn whenever the cadet is required to attend a function that otherwise would require a winter or summer dress uniform.
- During the duty day, cadets must be in UOD for all meals. Refer to the PT uniform section for exceptions.
- Civilian attire without a request is authorized for upper class cadets at the following times:
 - After 1700 hours Monday-Thursday. This includes dining facilities.
 - After 1400 hours on Friday, provided the cadet has completed all academic classes and Corps activities for the day.
 - On weekends, unless restricted due to participating in cadet obligations. activities, as directed by Regimental Staff.
 - When performing physical activities (i.e. gym, running, etc.)
 - When on leave.
- All cadets may attend off campus medical appointments in civilian clothes.
- Cadets shall not go to ROTC offices, the Commandant's office, Deputy Commandant's offices, or Senior Enlisted Advisor offices in civilian attire.




